Cuir Síos:

Is éard atá san fhorbairt ná cosán a thógáil ar an taobh thoir den L3205-0 ó Shráidbhaile an Locha Mór go dtí an Teachín, An Loch Mór (thart ar 100 méadar).

I measc na n-oibreacha tá soláthar córas tráchta toraidh a chuirfear i bhfeidhm ag Droichead an Iarnróid.

Beidh gá le trácht a bheidh ag taisteal soir a thabhairt agus beidh tosaíocht ag trácht a bheidh ag taisteal siar isteach sa sráidbhaile.

ROAD TRAFFIC ACT 1994

LOUGHMORE VILLAGE ACTIVE TRAVEL SCHEME, LOUGHMORE, CO TIPPERARY

Pursuant to the provisions of Section 38 of the Road Traffic Act, 1994, as amended by Section 46 of the Public Transportation Regulation Act 2009, Tipperary County Council hereby gives notice of its intention to deliver Loughmore Village Active Travel Scheme.

Description:

The development consists of the construction of a footpath on the east side of the L3205-0 from Loughmore Village towards The Cottage, Loughmore (approx. 100 metres.)

Works include the provision of a yield traffic system which will be put in place at the Railway Bridge.

Traffic travelling east will be required to yield while traffic travelling west into the village will have priority.

The road under the bridge will be reduced to one lane to a width no greater than 4.00m.

Works will also include provision of a new footpath which will be constructed to allow for the safe movement of pedestrians under the bridge and all associated site works.
