## 5.1 Cllr. Tony Black (Ref. ID 2625)

I call on this council to carry out improved traffic calming and safety measures on all approach roads into Tipperary Town. While I understand the enforcement of speeding laws is within the remit of An Garda Síochána, Tipperary County Council has a pivotal role to play in the process of ensuring the highest safety standards possible to protect motorists and pedestrians alike.

If the funds are unavailable at present, I request that all avenues are explored to secure funding to carry out these works that could potentially save lives.

## 5.2 Cllr. Declan Burgess (Ref. ID 2626)

That Management outline plans in this Municipal District for the 'Ready to Build' scheme. This scheme enables local authorities to make serviced sites in towns and villages available to potential individual purchasers (self-builders). These sites will be available at a discount on the market value of the site for the build.

### 5.3 Cllr. Michael Fitzgerald (Ref. ID 2627)

That this Council erect a wall between Oliver Plunket Park and Rockview Estate. Currently, there is a "green fence," but it is not sufficient, and a wall is required to help combat antisocial behaviour and littering and also to provide privacy for residents of both estates.

### 5.4 Cllr. Declan Burgess (Ref. ID 2628)

That this Municipal District reinstates a road crossing warden on the Cahir Road in Cashel. This is in the interest of road safety.

## 5.5 Cllr. Tony Black (Ref. ID 2632)

That this council will carry out an investigation at the Old Cashel Kings Hotel site on Dublin Road, Ballypadeen, Cashel. There are serious security and safety concerns at the site. This site needs to be assessed and if possible, added to the Derelict Sites Register for Tipperary.

I would also ask that this council interact with the developer and urge that property security fencing be installed around the site to prevent anti-social and criminal behaviour from occurring.

## 5.6 Cllr. Michael Fitzgerald (Ref. ID 2633)

That the Council attend to unblocking the shores and drains at Lower Main Street, Bansha as they are causing severe flooding.
