5.1 Cllr. Roger Kennedy (Ref. ID 2851)

That the Municipal District install a yellow box at the junction on Ladyswell Street and Francis Row in the interest of traffic safety and to facilitate exit from Halla na Feile, Francis Row and the Brothers of Charity at times of heavy traffic on the R693.

5.2 Cllr. Roger Kennedy (Ref. ID 2852)

That the Municipal District facilitate a plebiscite for the residents of William Street, Cashel to change the name back to its original name Lana Hackeid or Hacketts Lane, Cashel.

5.3 Cllr. John Crosse (Ref. ID 2854)

Due to the inappropriate behaviour of a small group of people near Kickham Plaza, it has been requested that the benches not be reinstalled at the same public location.

5.4 Cllr. Liam Browne (Ref. ID 2855)

That this Council erect suitable posts to stop vehicles parking on the pathway to St Cormac's Cemetery, from the new development at Bregawn, to outside the gates of the cemetery. Such posts would restrict vehicular parking, but allow full access to pedestrians and disabled transport such as wheelchair access and mobility vehicles.

5.5 Cllr. Liam Browne (Ref. ID 2856)

That this Council carry out or instructs the relevant authority to carry out inspection and repair works, to the bridge over the River Suir in the village of Ardmayle.

Also, that this Council carry out, or instructs the relevant authority to carry out painting work on the bridge (black/yellow paint), to make the safety threat on the bridge more visible, and reduce the possibility of traffic collisions/increase traffic safety.

5.6 Cllr. Declan Burgess (Ref. ID 2866)

That this Municipal District carries out a review of the pedestrian and traffic safety at An Úllord estate in Boherlahan. There is a significant need for the installation of a pedestrian crossing connecting An Úllord estate to St Joseph's Avenue.

5.7 Cllr. Liam Browne (Ref. ID 2867)

That this council provide CCTV monitoring for safety and security at Cashel Playground, Friar Street, Cashel and at the municipal car park on Friar Street, Cashel, adjacent to Roselawn and behind Cashel Library.

Both areas are the site of ongoing and significant criminal and anti social behaviour, which would benefit from continuous CCTV monitoring.

5.8 Cllr. Roger Kennedy (Ref. ID 2870)

French drains be put at suitable location where the resurfacing was done on the road into Limerick Junction from the turn off into the junction up as far as the station itself as water is collecting and flowing in driveways.

5.9 Cllr. John O'Heney (Ref. ID 2871)

That Tipperary County Council relinquish any interest in purchasing and developing a Roads Depot in Hollyford Village and instead expand and develop the depot that already exists in the area.

5.10 Cllr. John O'Heney (Ref. ID 2872)

That Tipperary County Council provides a Letter of Support to The Conference of St Francis, SVDP, Hollyford, to allow them access funding for social housing in Hollyford.

5.11 Cllr. John O'Heney (Ref. ID 2873)

That this Council would engage with Iarnród Eireann and the Department of Transport to request for an earlier Train Service from Tipperary Town Station that serves the Clonmel and Waterford regions.

5.12 Cllr. Marie Murphy & Cllr. Micheal Anglim (Ref. ID 2877)

That this Council would install ramps or 'speed cushions' on the approach to St. Mary's National School, Clogheen. The speed of traffic passing the school is extremely dangerous as proven by the speed tests done recently and this is despite the speed limit, the 'driver feedback signs', (which were installed about 8 years ago), the painting of the 'shark's teeth outside the school and the traffic calming measures done in the past couple of years.
