7.1 Councillor Richie Molloy (Ref ID 2911)

That Clonmel Borough District would install a cattle grid on the St. Patrick's Road entrance to the cemetery as there has been evidence of horses entering the graveyard in recent times.

7.2 Councillor Pat English (Ref ID 2912)

That Clonmel Borough District look at re-surfacing the section of the Heywood Road at Highfield Grove, Clonmel at the junction with the Frank Drohan Inner Relief Road. The existing road surface is in a very poor condition.
